FEEDBACK FROM THE BREAKOUT SESSIONS

New Remit of the Group

- mainstreaming/reaching out to grow the Good Food Movement
- Working nationally, sharing best practice
- procurement and catering local employability focus would reduce travel and carbon emissions
- Procurement LA rules can these be challenged? Example of North Ayrshire community wealth building focused tender changes including Climate requirements
- What can we learn from Brighton and Bristol? Tom from SFP recommends looking at reconfiguring supply chains to support jobs etc. Good employers needed who recognise collective bargaining etc.
- Preston model?
- Reference Circular Glasgow and/or Net Zero?
- add section on 20min liveable neighbourhoods? COVID closures making this more difficult

- General suggested changes in the exsisting document.

Roles and Responsibilities of Partners

- Elected members able to ask difficult questions push the agenda.
- Committing to sharing and disseminating information
- Ensuring opportunities for active involvement
- Lack of involvement of producers and industry? Should we try and involve them more. Also be clear on what they are being asked.
- Strengthen accountability having a designated lead in each member organisation who can make decisions and implement actions and attend meetings. Make more formal.
- Implementation of actions; who will be accountable for delivery of actions? It is role of partnership to hold organisations accountable?
- Steering group set up to make large decisions on behalf of the group
- minimum quorum of votes needed when taking a vote as a group/ Should decisions be made by majority vote or other?
- More formal commitment from larger partners ie statutory public partners? Partnership agreement of something similar... Shared commitments between organisations
- Third sector organisations to made pledges relate to general GFPP work or that of GCFP...?
- Getting commercial/other large organisations to pledge support for the plan
- Divide partners based on their specialist knowledge/interest. This could feed back to the specific GCFP thematic groups

Reporting Structure & Annual Review

- Connect to Health Oversight Board
- Strengthen communication of the Food Plan/ Communication of messages what capacity do we have? E.g. newsletter is this sufficient
- Communications group to meet close to annual reporting
- Need agreed targets and milestones? Themed GCFP working groups might want to report back to the rest of the group. Agree on KPIs and milestones to report.
- Evaluation of actions to be decided on
- Could we develop an app for easy sharing of reports/infographics/pictures?
- Utilise Social media platforms





- Share a public report in an engaging way; social media/'advertising campaign'/website
- Develop theory of change, project plan and monitoring framework early on
